## Member Account Privileges

All KGCC Members may have their own private charging account. To receive this, you must supply a credit card number. The credit card information is encrypted. The following conditions will apply to all charge accounts:

- Outstanding balances on the club account will be processed to the credit card on file, on the 1<sup>st</sup> day of every month.
  - IE: August 1<sup>st</sup> to 31<sup>st</sup> charges to account will be processed on September 1<sup>st</sup>
- On your personal credit card statements, you will notice two separate charges from us. If you have purchases in both the Golf Department and the Willows Restaurant, these will show up separately.
  - IE: Your total bill owed is \$300. \$200 of this was spent in the Pro Shop, \$100 of this was spent in the Willows Restaurant
  - Your statement will show \$200 towards the Pro Shop and another charge of \$100 for the Willows.
- Any account with an outstanding balance for 60 days, will be applicable to a 2% charge on the total amount owing and risk their membership being suspended until the account is cleared.

## 2020 COURSE LIABILITY AGREEMENT

---

This agreement shall apply to all rentals of golf carts provided by the Kamloops Golf & Country Club (herein "KGCC") and/or the golf professional retained by the KGCC to provide professional golf services (herein "the Professional") to members of KGCC and their guests. In consideration for the rental of the golf cart provided by KGCC and/or the Professional, I agree to the following terms:

1. I am familiar with the safe operation and use of the golf cart and any other instructions provided to me regarding the golf cart, including any policies pertaining to the proper use of golf cart on property of KGCC and on adjacent roadways, and will operate the golf cart in accordance with said instructions and policies.
2. I agree to contact KGCC and/or the Professional if I have any questions or concerns about operating the golf cart.
3. I agree that only persons who are 19 years or older shall be permitted to drive the golf cart. I further agree that I will not authorize anyone who is not familiar with the safe operation and use of the golf cart and any other instructions provided regarding the golf cart, including any policies pertaining to the proper use of golf carts of property of KGCC and on adjacent roadways to operate the golf cart.
4. I will operate the golf cart safely and responsibly, and I will preserve and protect the golf cart from loss or damage to the cart itself, my person or property, and the persons or property of others.
5. I agree that the maximum occupancy of the golf cart is two persons.
6. I agree that if I sign this form it means that should I be injured or killed for whatever reason while riding in or driving a golf cart, I cannot sue the Kamloops Golf & Country Club, its Board of Directors, Managers, Employees, Volunteers, or the Professional. I agree to this for all golf cart rentals I am operating during any round of golf at the Kamloops Golf & Country Club. I agree to hold harmless, defend and indemnify the KGCC and/or the Professional for any and all damages and claims of any nature whatsoever that may arise from the use of said golf cart by myself or others authorized by me, including but not limited to claims for damages to the cart itself, my person or property, and the persons or property of others I further agree to reimburse the KGCC and/or the Professional of any unrecovered costs, including but not limited to deductibles and any uninsured losses.
7. If I violate any of the above conditions, I agree that the privilege of using a golf cart can be revoked without notice by the KGCC in their sole discretion. I further agree I shall not be entitled any rental refund for such revocation of privilege and acknowledge that the privilege of future use of a golf cart on the property of KGCC may be suspended or revoked.
8. I agree that this Course Liability Agreement is made with KGCC and is in effect for all golf cart rentals until cancelled in writing by myself or the KGCC or the Professional; provided however that clause 6 hereof shall survive cancellation for any damages or losses occurring while this agreement was in effect.
9. I certify that I understand and agree to the conditions set fourth above. I acknowledge that I have signed this document voluntarily and freely and that my signature signifies a contractual obligation that binds me, my heirs, and successors.
